CONDITIONS

1. Should submit separate applications for each Category.
2. Receipt obtained from the Shroff of the CGF upon payment of the specified Registration Fee should be submitted with the application.
3. A Registration Fee of Rs.1000/- should be paid for each item.
4. Applications which do not comply with CGF requirement will be rejected without notice.
5. CGF reserves the rights to accept/reject any application without giving any reason and to select suppliers at its discretion and to select and obtain quotations & purchases from not-registered parties as well.
6. Letters from Principles of authorizing to market/service/supply of the products should be attached.
7. 45 days credit facility is a requirement. Any conditions to make payment before supply will be a disqualification.

8. Technical Evaluation Committee (TEC) will consider all applications and take appropriate action to register the successful/who fulfills all requirements.
9. Duly registered suppliers who fail to quote/supply goods under the specified time/not supply the goods as per specification or not provide quality good/services will be deleted from the registration.
10. The current list will become non-operative after issue of the list of registered suppliers for the year 2020.
11. The registration will valid until a new registration is made.
12. No additional transport charges will be made for all supplies, services to made to CGF offices in Colombo and in provinces.
